IMPORTANT DEADLINES

SEED RECEIPT: Untreated seed MUST arrive at Scottsbluff on ot before March 12, 2022

SEED QUALITY DATA: No.of seed/lb and seed germination % are needed to ensure PPA

PPA: 350,000/acre for rainfed 4 reps of 5 feet x 30 feet plot size

INNOCULUM: Seed will be innoculated with the same peat inoculum across the sites

DATA: 50% flowering, Physiological maturity, Plant height @ harvest, Yield, Test weight, Seed protein %

FEES: \$400/variety/site. 1/2 payment due before or at planting; remaining 1/2 after trial completion

Special Note: Prefer minimum ~10 entries/site and include for all sites. We will accept exception since pea industry is small.
